Telehealth Update

The primary focus of the teleaudiology expansion initiative was to increase the sites providing remote programming and fitting of hearing aids, while also providing the ability to complete remote audiometric procedures. As of August 2014, 57 of the 61 expansion locations were deemed operational. The remaining four sites are expected to become operational in December 2014.

The workload goal for FY 14 was 15,000 CVT encounters. As of Sept 30, 2014, we exceeded that goal with a total number of CVT encounters reaching 16,037. Equally as remarkable as the number of CVT encounters is the 50% increase in Veterans receiving teleaudiology care (FY 14= 10,776 Veterans, FY 13=7,200 Veterans). Additionally, teleaudiology workload activity is being reported in 20 of 21 Veterans Integrated Service Network (VISN) which is an increase from 17 VISNs in FY 13.

It is important to note that the impressive workload output and Veterans served is not just a result of the teleaudiology pilot/expansion project but also has been impacted by a number of other pilot, rural health, and facility initiatives. There are over 120 telemedicine carts with audiology peripherals that have been ordered or deployed nationally, suggesting that nearly half of the equipment available out in the Field has come from local or funding not provided by Telehealth Services.

In addition to the teleaudiology expansion initiative, all ten (10) pilot sites had equipment upgrades to ensure they had the same suite of equipment as expansion sites. This included speech mapping capabilities that were not available with original purchase. This also required migration to Windows 7 Gold Image workstation and installation of software packages through Microsoft System Center Configuration Manager (SCCM) to ensure consistency with standard network configuration that did not exist when the pilot began. This lack of standardization created significant variability in site-to-site performance, limited the use of the enterprise desktop sharing application (Lync), and impeded the ability of staff to effectively receive software updates and basic troubleshooting support through the National Telehealth Technology Helpdesk. This upgrade, although critical to adhering to the standardization needs and enterprise infrastructure, created significant delays in deployment of the remote audiometry initiative within the original pilot sites. Integration of the prototype sound level meter was another factor in delaying the reception of anticipated outcome data.

Pilot results, per established protocol (air conduction thresholds, 10 ears/site), have been reportedly completed at six (6) of ten (10) sites tasked with moving remote audiometry phase forward. Data analysis of clinical outcomes is being completed and results will be released to Program Office and Telehealth Services as soon as report can be written. There is a current effort to move into a full diagnostic test battery. In addition to protocol adjustments and supplemental materials, contact has been made with the Clinical Video Telehealth (CVT) National Training Center to consider creating a national curriculum for remote audiometry.
