





President's message:



Since 2004 he has taught classes in aural rehabilitation, professional issues and vestibular diagnostics and rehabilitation at the University of Arkansas for the Medical Sciences/ University of Arkansas- Little Rock's Doctor of Audiology (Au.D.) program. He has published in the area of vestibular evaluation which is his primary clinical interest. He is a native of St. Louis, MO but currently calls Hot Springs National Park, AR home.

Dr. McCoy has been a board member of both the California Academy of Audiology and the Arkansas Academy of Audiology as well as active in national organizations. He is eager to bring his experience and passion for advocacy of the profession to the AVAA board.

Spotlight on: Scott Forbes, Au.D., Receipt of the first Robert Pluta Distinguished Service Award

The JDVAA board awarded the first Robert Pluta Distinguished Service Award at this year's Joint Defense VA Audiology Conference. This reward was created in honor of Major Robert S. Pluta and is presented to an audiologist who has demonstrated outstanding service to both the Department of Defense and Department of Veterans Affairs in support of the audiology and/or hearing conservation professions. Candidates for this award have made significant contributions to the field while seamlessly crossing between the Tri-Service and Veteran domains.

Lieutenant Colonel Scott Forbes, Au.D. was selected as the recipient of this award for his outstanding contributions to both Military and VA Audiology.

Dr. Forbes recently completed his 28th year of military service and his 19th year of service as a VA clinical audiologist. His military career began when he enlisted in the United States Marine Corps following high school. That initial enlistment included six years of active duty with combat deployments to Desert Shield/Desert Storm and Operation Restore Hope in Somalia. Following his release from active duty service, Scott enrolled as a student at Louisiana State University. While completing his undergraduate and graduate degrees in Audiology at LSU, he continued to serve in the Marine Corps Reserve as a platoon leader in a heavy weapons company. Dr. Forbes completed a paid traineeship at the New Orleans VA Medical Center during his final year of graduate school and upon graduation he accepted a permanent position with the Michael E. DeBakey VAMC in Houston.

Following completion of his clinical fellowship year, Dr. Forbes was commissioned in the U.S. Army Reserve. He has twice been mobilized to active duty as an Army Audiologist and Hearing Conservation Officer in support of the Global War on Terror; first to Fort Hood, Texas (2003-2004) and then to Fort Knox, Kentucky (2006-2007). In addition to his assignments as an Audiologist, he completed assignments as a company commander, a battalion operations officer and as a command and control observer-trainer. In his current assignment, Lieutenant Colonel Forbes serves as the Army Reserve Audiology Staff Officer to the Army Surgeon General. His work in this role supports the development and implementation of strategic Army Audiology and Army Hearing Program Policy. Additionally, he supervises the selection of Army Reserve audiology officer candidates, develops reserve component audiology and hearing conservation staffing models and training materials, and evaluates and implements initiatives and strategies for system-wide hearing conservation compliance for the U.S. Army Reserve Command.

Dr. Forbes has made numerous contributions to VA and DoD Audiology. He is a past president of the Association of VA Audiologists and a former Vice President of the Joint Defense Veterans Audiology Association. He has been a strong advocate for collaboration between VA and DoD Audiology and has demonstrated that commitment through his many years of volunteer work with the Joint Defense Veterans Audiology Conference, having ultimately served as conference education chair and conference program chair in past years. Dr. Forbes was an important contributor to the early work of the DoD Hearing Center of Excellence. He provided ongoing technical consultation to HCE leadership concerning VA hearing loss and tinnitus disability issues and DoD Separation Health Assessment evaluations, edited the HCE's clinical education online resource site and assisted in the implementation of the HCE's Comprehensive Hearing Health Program in VA clinical settings. Dr. Forbes currently serves as a VA advisor to the HCE's Joint Hearing and Auditory Systems Injury Registry.

Dr. Forbes has also made meaningful contributions to VA Audiology through his participation in numerous committees and working groups. He currently serves as a member of the national hearing aid contract technical team. This group is responsible for defining criteria and writing the national hearing aid contract, as well as evaluating and approving all devices considered for contract inclusion. Dr. Forbes currently serves as Secretary of the Southeast Region Audiology Professional Standards Board, is a member of the Audiology Health Tech Education Working Group and is a VA Manager for DOEHRSHC. He was also a member of the VA working group that developed current best practice recommendations for tinnitus management. Dr. Forbes was also recently appointed to the Field Advisory Council.

Lieutenant Colonel Forbes and his wife Kellie reside in Kingwood, Texas. They are the parents of four sons: Jacob, Caleb, Adam and Daniel and recently became grandparents with the birth and adoption of their granddaughter, Liliana.

In regards to receiving the Pluta award, Dr. Forbes stated *“I was both honored and touched to receive this award. Rob was a friend, which makes this all the more special. When you listen to people who knew Rob speak about the kind of person he was, you will consistently hear words such cheerful, kind, selfless and humble. Rob had many talents, was always willing to use them to help others, and never wanted any credit or attention for his efforts. Rob lived his life serving others and it’s appropriate that we remember him by honoring that legacy.”*
