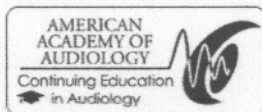

Guidelines Summary for ABA Tier 1 CE Providers*

- Inform participants about Tier 1 hours. Include required verbiage
- Notify participants of the requirements of completion
- Activity or presentation must be at least 3 hours duration with a form of outcomes measure or assessment
- Notify presenters of the Presenter Guidelines (guidelines found in the link below)
- Review the assessment tool in conjunction with material to ensure that the assessment corresponds with the activity
- Assessment tool may be multiple choice, true/false or both. If the assessment questions are multiple choice, there must be a minimum of 4 choices per question.
- Provide sufficient copies of the learner assessment tool
- Review and score the assessment tools. A minimum passing score of 80% is required
- Submit a list of ABA certificants who participated in the CE activity along with the assessment scores to the Academy
